**END-USER LICENCE AGREEMENT  
FOR SOBEK TECHNOLOGIES INC.'S Geotab Application  
IMPORTANT NOTICE - READ CAREFULLY**

Please read this End-User Licence Agreement (EULA) carefully before installing or using Geotab. By installing, accessing, copying or using the application, you accept and agree to be bound by the terms of this agreement. If you do not agree to all the terms of this agreement, you must not install, access, copy or use the application.

This EULA is a legal agreement between you, the Licensee, and Sobek Technologies Inc. (Sobek) for the software product(s) accompanying this EULA, which include(s) the application and may include "online" or electronic documentation, associated media, and printed materials.

**A - DEFINITIONS.**

**Admin Password** means the password provided by Sobek to the administrators of the Licensee. The Admin Password is used to register tablets with their Android ID.

**Android ID** means the unique identification to each Android tablet. Each Android ID must be registered with the User Code and Admin Password to be listed as part of the Licensee's tablets.

**Application** means the Geotab application for Android tablets.

**Date of Rental** means the date a shared licence was rented, and User Code and Admin Password were sent to the user, if applicable.

**Documentation** means the user guide, help information and/or other documentation provided by Licensor with the Software.

**EULA** means end-user licence agreement.

**Licence** means access to the use of Geotab for a period of 1 month to 1 year, renewable. A licence is always Shared.

**Licensee** means the User, together with the business or other entity for which the Software is obtained.

**Licensor** means Sobek Technologies Inc. 4205 Northcliffe, Montreal, Quebec, Canada H4A 3L2 and its subsidiaries (collectively, "Sobek").

**Shared Licence** means a licence that allows one concurrent user the access to Geotab. A shared licence must be activated by entering the User Code. A shared licence can be deactivated at any moment to become available to another user. The tablet's Android ID must be registered via an Admin Password before a Licensee's shared licence can be activated on the tablet.

**Software** means any Licensor computer program (in object code) accompanying this EULA.

**Technical Support** means the assistance to the users by telephone, emails or online meeting software for answers to precise questions regarding software operations.

**Updates** means any patch, modification or new version of the Software.

**User** means you, the individual who accepts this EULA, not any other person.

**User Code** is an identification number specific to each licensee and provided by Sobek. It is used to activate or deactivate a shared licence from Geotab.

**B - GRANT OF LICENCE.** Subject to the terms and conditions set forth in this EULA, Sobek grants you a non-exclusive, non-transferable, non-sublicensable right and licence to use Geotab. A shared licence is limited to one concurrent user having access to Geotab via an activated licence. All updates are deemed to be part of the Software, and are subject to this EULA. They can be downloaded and installed. The technical support and the maintenance are included with the rental for a period of 1 month to 1 year of a shared licence.

After downloading Geotab, you may not: (1) distribute, rent, transfer, lend, lease, sublease, or sublicense all or any portion of Geotab; (2) modify or prepare derivative works based on Geotab; or (3) reverse engineer, decompile, or disassemble Geotab. You agree to keep confidential and use your best efforts to prevent and protect the contents of Geotab from unauthorized disclosure or use. You are responsible for the installation, management, operation, and results obtained from Geotab.

**C - COPYRIGHT.** The Software is the intellectual property of and is owned by Sobek. The structure, organization and code of the Software are the valuable trade secrets and confidential information of Sobek. The Software is protected by law, including without limitation the copyright laws of Canada and other countries, and by international treaty provisions. Except as expressly stated herein, this EULA does not grant you any intellectual property rights in the Software and all

rights not expressly granted are reserved by Sobek. Except as otherwise noted in this EULA, you shall not cause or permit unauthorized copying, reproduction, or disclosure of any portion of the Software, or any Documentation, or the delivery or distribution of any part thereof to any third person or entity, for any purpose whatsoever, without the prior written permission of Sobek. You may not reverse engineer, decompile, disassemble, or otherwise analyze the Software, or knowingly allow others to do so. Any person who does not respect these rules is guilty of infringement and is punishable by law.

**D - UPDATES.** Sobek creates updated versions of the Software. These updates are available on Sobek's website to the Licensee. The Licensee may download and use the updates of the Software.

**E. TECHNICAL SUPPORT SERVICES.** Sobek may provide you with Technical Support services related to the Software. Any supplemental items including documentation and style files provided to you as part of the Technical Support services shall be considered part of the Software and subject to the terms and conditions of this EULA. With respect to technical information you provide to Sobek as part of the support services, Sobek may use such information for its business purposes, including for product support and development. Sobek will not utilize such technical information in a form that personally identifies you, and Sobek will not use any confidential data without the consent of the Licensee.

**F. DISCLAIMER OF WARRANTY and LIMITATION OF LIABILITY.** The licensed Software and Technical Support services are provided "as is" without warranty of any kind. The Licensor does not warrant that the licensed products or support services will meet the Licensee's requirements or that they will be uninterrupted or error-free. To the fullest extent permitted by law, the Licensor hereby disclaims all other warranties, whether express or implied, oral or written, with respect to the licensed products and support services including, without limitation, all implied warranties of title, non-infringement, quiet enjoyment, integration, merchantability or fitness for any particular purpose and all warranties arising from any course of dealing, course of performance or usage of trade.

Under no circumstances shall Sobek be liable to you or any other party for indirect, consequential, special, incidental, punitive, or exemplary damages of any kind (including lost revenues or profits or loss of business) resulting from this EULA, or from the furnishing, performance, installation, or use of the Software, whether due to a breach of contract, breach of warranty, or the negligence of Sobek or any other party, even if Sobek is advised beforehand of the possibility of such damages. To the extent that the applicable jurisdiction limits Sobek's ability to disclaim any implied warranties, this disclaimer shall be effective to the maximum extent permitted.

**G. GOVERNING LAW.** This EULA is governed by and construed in accordance with the laws of the Province of Quebec, Canada, without regard to its conflicts of law provisions.

**H. SEVERABILITY.** If any provision of this EULA shall be deemed invalid or unenforceable, the remainder of this EULA shall remain in full force and effect. To the extent any express or implied restrictions are not permitted by applicable laws, these express or implied restrictions shall remain in force and effect to the maximum extent permitted by such applicable laws.
